NOTE: The use of IMF Credit under stand-by agreement is recorded as Turkish Lira liability in the CBRT Weekly Statement under the heading "Deposits by International Organizations" at the prevailing TRL/SDR exchange rate on the date of withdrawal. However, in the Analytical Balance Sheet, SDR liability is considered as a foreign liability and marked to market. Exchange rate differences accumulated between the date of withdrawal and the date of Analytical Balance Sheet is recorded to Fx revaluation account.
