#### **Country Note**

1)(\*) Section II-1: Foreign Exchange Deposits by citizens abroad with Central Bank (named as Dresdner deposits) covered under the section II-1 of the template were only those with one year original maturity up to February 2002. Beginning from February 2002 template, Dresdner deposits with remaining maturity of one year or less (without considering the original maturity of these deposits) are reported in section II-1 of the template as predetermined drains with principal and interest payments breakdown.

2)(\*\*) Section III-1-b: Dresdner Deposits with remaining maturity of more than one year, which were not shown previously, are reported in section III-1-b of the template under “other contingent liabilities” in total beginning from February 2002 template. Considering the withdrawals (generally interests are capitalized and the accounts rolled-over) and the long-term trend of these accounts, significant outflows are not seen even in times of serious financial crises. So these callable deposits are treated as contingent liabilities.

3)(\*\*) Section III-1-b : Commercial banks' reserve requirements in foreign currency held at the Central Bank of Turkey are classified in section III-1-b of the template under “other contingent liabilities” as total beginning from February 2002 template.
