PRESS RELEASE ON FOREIGN EXCHANGE DEPOSIT INTEREST RATES

In line with global interest rate developments, the rates applied to banks' one week maturity borrowings from the Central Bank have been reduced from 7,5 percent to 4,5 percent for USD and from 6,5 percent to 2,5 percent for EUR, effective from March 10, 2015.
