- "I.A. Official Reserve Assets" item includes foreign currency transactions with non-residents as well as transactions with residents.
- "Share Participations" and "Other Assets/Other" items in the balance sheet of the Central Bank are not liquid assets according to the IMF's reserve definition. Hence, they were excluded from "I.B. Other Foreign Currency Assets" section as of January 2013.
- Commercial banks' reserve requirements held at the Central Bank as foreign currency and gold are classified in section III-1-b of the template under 'contingent liabilities' as total. Standard gold held as required reserves recorded USD 8206 million in November 2020.
